**INFRACTION DEFERRAL AGREEMENT**

Comes now the Town of St. John, by the Municipal Corporation Attorney, and the Defendant, and enter into this Infraction Deferral Agreement pursuant to I.C. Sec. 34-28-5-1 et seq. and Town Ordinance. The Town of St. John agrees to defer prosecution and to dismiss the charge of violating Ordinance 511, IF AND ONLY IF, the Defendant complies with each and every term contained herein.

SECTION I The Defendant agrees:

- (a) to pay initial user's fees, monthly user's fees, and court cost in the total amount of **\$192.50**
- (b) to not commit a criminal traffic offense of moving traffic violation for a period of six (6) months from the date of Court approval of this Agreement.

SECTION II Defendant affirms under the penalty of perjury pursuant to I.C. Sec. 35-44-2-1 that:

- (a) all of the information herein is true and accurate:
- (b) this violation is not associated with an accident, property damage, or other criminal traffic offense;
- (c) I have not been charged with a criminal traffic offense or been issued a moving traffic violation within the last year in any State; and
- (d) I have not been charged with a speeding offense in excess of (30) miles per hour over the posted speed limit.

SECTION II The Defendant acknowledges and agrees that failure to comply with Sections 1 and 2 above may result in the Municipal Corporation Attorney immediately setting this cause for initial hearing on the Court Docket. The Defendant understands that this will result in forfeiture of fees paid.

I, the Defendant, have read and understand all of the provisions of this Agreement, and I accept them as binding upon me and enter into this Agreement of my own free will.
