

St. John Seeking Upscale Dining Development

The Town Council approved an Ordinance to authorize 10 additional liquor licenses as part of a state law which designates waterways as development project areas. This is permitted under the state's Riverfront Development laws, even though St. John and other communities do not have riverfront, designated and named waterways qualify under the law.

The intention of this action is to promote food oriented dining development along the US-41 corridor. These are site specific licenses, meaning that a licensee cannot simply move to a location and retain the license. These are not to allow establishments like bars or nightclubs, rather food oriented businesses as the primary business and alcohol as a secondary revenue source.

St. John is working with commercial developers to bring in more upscale dining options for residents and visitors to keep local dollars here in town.

TOWN MOVING FORWARD WITH \$3.8 MILLION ROAD PROJECT

93rd Avenue/US-41 Roadway Improvement Plan

The Town is completing the award of a \$3.8 million contract to F. H. Paschen for roadway improvement at 93rd Avenue West of US-41. The project is meant to improve traffic flow east and west along that highly traveled roadway. This project will have two turn lanes from Eastbound 93rd onto US-41 to allow for better flow and less backups. It will allow a through lane and right turn lane from eastbound 93rd Avenue. Improvements will continue there allowing a left turn lane onto Keilman Street and an East-West turn lane from Keilman Street.

This project will begin in March/April and will be completed by November/December of 2023. There will be lane restrictions and closures at times along this route so stay tuned for announcements. As part of this expansion, the old parsonage at St. John the Evangelist Parish will be demolished and a new sidewalk will be installed to allow for better and safer pedestrian access.

Utilities will be relocating utilities which will include removal of some NIPSCO poles along this area to allow for underground services.

Additional improvements include a new 12" water main installation along 93rd Avenue under US-41.

\$2.3 Million in Road Projects for Community Crossing Grant

The Town of St. John has submitted application to the Indiana Department of Transportation for \$1 million matching grant through the state's Community Crossing Matching Grant (CCMG). The Town has planned \$2.3 million in roadway improvements for the summer of 2023 which includes:

- 93rd Avenue (from Fairbanks to Deodor)
- Deodor (from Elle to 89th)
- Parrish (from 89th to 85th Avenue)
- White Oak (from 93rd Avenue to 109th Avenue)


From the office of Chief Steven Flores

First, is our body worn cameras. We recently received a grant for the cameras and the officers have been testing them out for the last couple of months. Now that we have the bugs worked out, we are fully using them on patrol which helps tremendously not only with transparency, but with our investigations. Many times, when offenders know or see the camera on the officers, it tends to deescalate situations by simply them knowing they are being recorded. They are also very useful by corroborating cases that officers file charges on. Second, with the help of two of my officers, we started a crisis intervention program. Sergeant Lukasik and Officer Wartman both have master's degrees in psychology and Officer Wartman is a certified addiction and crisis intervention officer/ counselor. Officer Wartman has used his skills numerous times while working, assisting residents who suffer from mental illnesses, suicidal thoughts, and substance abuse. There are not very many shifts that go by where he doesn't use his crisis intervention skills. We are also working on bringing on a clinical counseling intern from Indiana University Northwest to assist with the program. We are hoping to have someone on board by May. Officer Wartman is also in the planning stages of providing law enforcement officers across the entire region with a 40-hour crisis intervention training. This training is very similar to the one the Illinois State Police just implemented. The program has been extremely helpful to people who need it, and it's getting busier and busier.
