

MILL CREEK ROAD PROBLEM STATEMENT SUMMARY

- Mill Creek Road *has not been* completed by Olthof Builders extending and connecting to Parrish Ave in St. John
- Contacted / Discussed with Olthof Land Management on May 20, 2020:
- No schedule is proposed
- No future commitments for completion of this project
- Due to economic uncertainty and COVID no work is planned
- Builder had all of 2019 to complete work.
- Builder continues to work on homes in process.
- Other developments infrastructure started without completing current developments.
- See Birchwood Farms US 41
- Increased Construction Traffic through residential neighborhoods without additional road access
- Increased Laborers observed speeding through the neighborhood
- Example of Vendors by Trade (Excavating, Cement, Carpentry, Electrical, Plumbing, Drywall, Painting, Insulation, Roofing)
- Pollution and Noise Control from Traffic
- Police, Fire and Medical inability to ingress the property via additional routes



Dear Commissioner Tippy

I briefly spoke with Councilman Mr. Gerald Swets of St. John. He recommended during our conversation to reach out to you on behalf of the Mill Creek community and our concerns.

I will soon be submitting information to the St. John Council for entering the May meeting minutes. This will request Olthof Builders to complete the Mill Creek Road out to Parrish Avenue in St. John. The homeowners will soon file a petition for the Mill Creek Road initiative. Based on current events, we will look to present our findings at the June meeting in St. John.

Currently, Mill Creek has only one ability to egress the property as it continues to build out. This concerns homeowners based on safety and construction traffic issues. I have attached a map of the community for your review. To date, there are slightly over 100 single-family home sites with 81 completed or nearing completion. Many of these homes include children. It is time and necessary to limit construction traffic, but also provide support for police, fire and medical in having the ability to enter the community via alternative routes. As the plot indicates, most remaining single-family homes could be serviced from Mill Creek Road as the remaining ones will reside in only two remaining cul-de-sacs. In the townhome section, several two-family units are complete with many seniors living in the area. Completing Mill Creek Road will also help to alleviate turning left out of Mill Creek onto US 231 which creates a safety issue. I have spoken to Land Management of Olthof Builders and they have stated there are no current plans or any schedule to complete this road at this time due to economics/COVID. I realize this is an expense to the builder however they continue to build in Mill Creek without an additional street to exit the community and had all of 2019 to complete this road. Economies of scale for a

project come to mind. The remaining portion of Mill Creek Road is approximately 300 yards from the current pavement to Parrish and is marked **RED** on the plot to signify the road. A picture is included for your review. I might add Olthof continues to build out infrastructure elsewhere such as Birchwood Farms in Cedar Lake on US 41 without one home built: starting another initiative without completing a prior development.

We are also creating a second initiative that will include the Gates community on a separate petition to install a trip stop light at Park Place Drive and US 231. This is denoted as **RED** on the plot as to the location. Based on observations, there is a similar stop light already installed at 109th and Olcott.

In our opinion, the 109th/Olcott intersection does not conform to traffic statistics based on IDOT guidelines but is in installed and in use. Previous IDOT engineering studies have stated there is not enough traffic coming from the Gates and Mill Creek to support a stop light at US 231 and Park Place Drive. To the west and east of us on US 231 there are lights at Parrish and Cline Avenue. This second petition will demonstrate the community disagrees with IDOT. Perhaps these studies were done a while back before the communities were built out. The Gates community sits directly north of Mill Creek and is mixed use with single family homes, townhouses, and a Christian School with approximately 600 students and no bus service. The Gates also has Providence Park Place Senior Living where many residents still utilize their own transportation. A new church has been built with a second church on the way. There are also connecting walk and bike paths from the Gates to Mill Creek that cross US 231. No available light presents several issues accessing US 231 going west from Mill Creek since this is our only option to exit Mill Creek. During school drop-off and pick-up as well as rush hours this is a major safety concern with the amount of traffic that traverses US 231 and driver sightlines. Although a trip light at this intersection is important for safety reasons, I realize the Gates has many egress avenues out to Parrish and Cline. For Mill Creek, this is a different story.

Perhaps there is a win-win situation in the near term for the state and county from an expenditure point of view. Since the Gates can traverse and egress many ways, the focus and priority would be to complete Mill Creek Road which would virtually eliminate all left-hand traffic from Mill Creek onto US 231. The completed road would support police, fire, and medical personnel as well as reduced construction traffic out of the main residential areas already developed. Please be aware Cedar Lake provides school bus service for all schools in Mill Creek turning out onto US 231.

How can you assist us in this endeavor in moving this forward? We are again looking to engage the St. John Council for support as well as reaching out to Police and Fire for their support.


